I understand that admission as a non-degree-seeking student does not constitute admission to a master’s or doctoral degree program at Texas State, nor does it imply that satisfactory work will guarantee admission to a degree-granting program. (Courses taken will be shown as “post-baccalaureate” credit on your Texas State transcript. If you are admitted to a degree program, up to six hours of graduate-level courses completed with a grade of “B” or better may be petitioned for degree credit.)
