Required application documents:

Undergraduates: Please download and attach your Degree Audit Report (DAR) to the application.

Post-Baccalaureate and Graduate students: Upload your certification plan and attach it to the application. If you do not have a certification plan on file, you MUST apply for one immediately through the Office of Educator Preparation website:

Starting on **March 1, 2017**, log back on to ePortfolio to view your application status: "Tentative" acceptance indicates you have outstanding coursework. "Outstanding coursework" are any remaining coursework (including your current classes) that you must complete and pass before student teaching. The Office of Educator Preparation will secure a placement for you, but **all coursework** must be completed successfully before you can start your student teaching experience.

Undergraduate students: All coursework must be completed before student teaching. **Post-Baccalaureate and Graduate students**: All certification coursework (listed on your certification plan) must be completed before student teaching.

Clearing Outstanding Coursework: The Office of Educator Preparation will work with your certification program to verify your successful completion of required coursework. Some of the courses listed may be in progress and may not be cleared until the end of the semester. If you have courses from another university, it is your responsibility to submit proof of those grades to our office by July 31, 2017.

You may not take additional courses with student teaching.

All school districts require a cleared criminal history check (and in many instances, fingerprinting) PRIOR to beginning your student teaching placement.

NOTE: If you feel there might be a problem with your criminal history check, please contact the Director of the Office of Educator Preparation at Texas State University immediately.

Some school districts require student teachers to provide TB Test results. Once you know which school district has your name for placement, you will need to check their HR website to determine if they require TB tests for new employees. If they do, plan to have one taken at the University Health Center.

Criminal History

The Office of Educator Preparation will send your name and placement request to your first district preference (as indicated on your application for student teaching). District administrators will choose your specific campus/teacher assignments.

NOTE: Do not contact the districts directly.

During the week of April 1, 2017, you will receive an email with the following information:

- Where we submitted your name/placement request;
- Information about district orientation, if available;
- Links to required Danielson Training online modules; and,
- A reminder about testing/fingerprinting for TEA certification.

If the school district is unable to place you, The Office of Educator Preparation will submit your name to your second choice preference for placement. At that time, you may be required to submit another background check.
