In the court segment you will enter the termination information in the disposition fields, not the original disposition:

- Court ORI
- Cause Number
- Offense Data
- Final Plea
- Court Disposition Date – Enter the original disposition date.
- Sentence Date – Enter the date of the termination.
- Court Disposition – Use the CDN **400** – Community Supervision Expired
- Court Provision – Use the appropriate CPN – Required with CDN 400
 - 393** – Deferred Completed and Charges Dismissed
 - 394** – Deferred Completed

To use the CDN 393 the court documents must contain information that specifies the case is to be Dismissed if completed. If this is not present in the court documents, then the CPN 394 must be used.
